POINTS AND AUTHORITIES 1 2 Courts of general jurisdiction have a statutory as well as inherent duty and power to control their 3 own processes and orders so as to make them conform to justice, including the granting of a trial continuance in a proper case. Code of Civil Procedure Section 128(8) states: "(a) Every court shall have 4 5 power; (8) to amend and control its process and order so as to make them conformable to law and justice." See also, California Cotton Credit Corporation v. Superior Court (1932) 127 Cal. App. 472. 6 7 On a showing of good cause a court may grant ex parte leave to shorten the time required for service of notice of hearing on a motion. Code of Civil Procedure Section 1005 (b). 8 The concept of good cause implies a factual showing that a reasonable ground exists for the 9 requested order, i.e., a good reason for excusing performance of a duty imposed by statute. Waters v. 10 Superior Court (1962) 58 Cal.2d 885, 893, 27 C.R. 153, 157. 11 As is disclosed by the attached declaration, good cause exists for the requested order in that trial is 12 ESCRIBA LA FECHA DE .
